Veterinary regulations: a dog who will be exhibited in Latvia, must be vaccinated against rabbies (the validation of the vaccination in accordance with the vaccine's producer advise) and must have distinct identification (microchip).

NB! Entry fee should be transferred to LKF account in full amount (please check bank charges)! Cheques will not be accepted! Day of registration is when all documents are received and entry fee is received on bank account! Otherwise registration will not be accepted in specified date and fee can be change due the time period of registration. Please check data and fee in time period table.
